

#### Introduction

Federal Transit Law requires that projects selected for funding under the Elderly Individuals and Individuals with Disabilities (Section 5310) programs be derived from a locally developed, coordinated public transit-human services transportation plan. The purpose of the plan is to identify the transportation needs of individuals with disabilities, older adults, and people with low incomes, provide strategies for meeting these needs, and prioritize transportation services for funding and implementation.

SEAGO recognizes that the transit environment is dynamic and ever changing. As a result, SEAGO reviews and updates the plan on an annual basis. This Plan Update includes updated regional demographic data, transit capacity building strategies, as well as updated information on new and existing transportation providers serving the transportation dependent and disadvantaged populations in the region.

SEAGO utilizes a process that includes representatives of public, private and nonprofit transportation and human services providers, elected officials, and public participation identify transit needs/service gaps and to establish priorities in order to make informative funding decisions for specialized transportation services.

This plan update will focus on the 2016-2017 State fiscal year and will be updated once again in March of 2018.

#### Title VI

#### The Federal Transit Administration (FTA)

Federal Transit Administration (FTA) Section 5300 Rural Public Transportation Programs provide funds for capital, administrative, operating, and training assistance to local public bodies and nonprofit organizations for the operation of public transportation services in non-urbanized areas. The following FTA Programs are available in the SEAGO Region:

#### TRANSIT/TRANSPORTATION PROGRAMS

#### Section 5310 - Enhanced Mobility of seniors and Individuals with Disabilities

The purpose of the Section 5310 Program is to improve mobility for seniors and individuals with disabilities by removing barriers to transportation service and expanding transportation mobility options. This program supports transportation services planned, designed, and carried out to meet the special transportation needs of seniors and individuals with disabilities in all areas – large urbanized (over 200,000), small urbanized (50,000-200,000), and rural (under 50,000). Eligible projects include both traditional capital investment and nontraditional investment beyond the Americans with Disabilities Act (ADA) complementary paratransit services. SEAGO has over 15 programs that receive Section 5310 funding.

#### Section 5311- Rural Area Formula Grants

This program provides capital, planning, and operating assistance to states and federally recognized Indian tribes to support public transportation in rural areas with populations less than 50,000, where many residents often rely on public transit to reach their destinations. It also provides funding for state and national training and technical assistance through the Rural Transportation Assistance Program. Benson, Bisbee, and Douglas operate 5311 programs within the SEAGO Region.

#### Section 5307 - Urbanized Area Formula Grant

The Urbanized Area Formula Funding program (49 U.S.C. 5307) makes Federal resources available to urbanized areas and to Governors for transit capital and operating assistance in urbanized areas and for transportation related planning. An urbanized area is an incorporated area with a population of 50,000 or more that is designated as such by the U.S. Department of Commerce, Bureau of the Census. Sierra Vista is the only 5307 operator within the SEAGO Region.

#### **SEAGO and Regional Mobility Management**

SEAGO is a regional planning agency which performs and coordinates a variety of functions. Established in 1972, SEAGO is a 501(c) 3, nonprofit organization whose mission is to assist local governments in seeking cooperative solutions to area wide problems; to provide a forum for regional policy development and serve as a coordinating link between municipal, county, tribal, state, and federal agencies. SEAGO is one of six Arizona Councils of Governments (COGs). SEAGO serves the four counties of Cochise, Graham, Greenlee, and Santa Cruz. Together they comprise 13,946 square miles of rural area with per capita income below the state and national averages.



SEAGO's Regional Mobility Management program is a result of federal and state

mandates for increased coordination efforts with a focus on expansion of services and greater cost efficiencies. The goals and objectives of the program include:

- Provide greater public access to transportation and transportation information;
- Provide support to existing local mobility managers and transportation providers;
- Identify ways to fill gaps in the provision of transportation services;
- Identify ways to ease barriers and reduce costs for transportation providers;
- Act as a conduit between transportation providers and transportation funders; and
- Act as an advocate for the development of federal, state, and local policy that supports
  the advancement of rural transportation opportunities and stated goals.

Within the SEAGO region, local governments and human services providers have come together in an effort to maximize scarce resources and build efficiencies that will better serve the residents of the area. In that same spirit, providers of public transit programs and special needs transportation services have conceived this coordination plan as a means to establish and improve transit and transportation services for the four county regions. This Coordination Plan was developed by the SEAGO Transportation Department in cooperation with transit and transportation providers throughout the region. The Plan has been approved by the SEAGO Executive Board and updates are submitted to ADOT on an annual basis.

#### The Goals of the Coordination Plan

The SEAGO Region Transit/Transportation Coordination Groups coordinate their efforts and communications in order to provide information and guidance to federal, state and local government officials as well as transportation/transit service providers for the purposes of policy development, decision making, and investments needed to create greater efficiencies, build capacities and address gaps in service.

In addition, the Coordination Plan serves as a catalog of transit and transportation services available in the region. Its content is made available on the SEAGO website, <a href="www.azmobility.org">www.azmobility.org</a>, for use by the general public and by organizations serving persons in need of transit/transportation services.

As funding priorities shift during this uncertain economy, information shared on a region wide basis enables smaller agencies to coordinate with larger providers to cover gaps in service, and for all members to implement the best usage of monies, equipment, and personnel.

While each member organization has its own goals and objectives for its transit/ transportation programs, common issues are often served by collective solutions. The goal of this coordination plan can be summarized more simply as a desire to meet the transit/transportation needs of the region's citizens in a safe, reliable, accessible manner that maximizes the use of resources and minimizes the cost to provide said services.

#### The Coordination Process

Coordination meetings are held in Cochise, Graham, and Santa Cruz Counties each quarter. The meetings provide an opportunity for rural area governments and organizations to discuss ways they can improve their services and share information pertinent to the success of their transit operations. They are able to share resources through program management and driver training, vehicle maintenance and repair, route coordination, program planning, and funding strategies. In addition, organizations work together to determine how to fill gaps in rider services, and to conduct geographic outreach.

These Coordination groups consist of public and human services transportation providers, local elected public officials, local government representatives, the general public, social service and faith-based agencies that represent the elderly, individuals with disabilities, veterans, low income, domestic abuse, and youth programs. In addition, ADOT staff participates in Coordination meetings at various times throughout the year and provide valuable guidance, data, and resources. ADOT also supports the coordination effort by holding statewide meetings and conferences that allow providers to learn about and model other successful programs.

The Regional Mobility Manager and Assistant Regional Mobility Manager facilitate meetings in Cochise, Santa Cruz, Graham/ Greenlee Counties, disseminate information to members, assist in identifying gaps, and encourage collaborative efforts.

Annually, each coordination group come together to form the Regional Coordination Council. New members are added to the Plan and organizations no longer active are removed from the Plan. Each organization is given an opportunity to update their own efforts and the combined efforts of SEAGO 2017-2018 TRANSPORTATION COORDINATION PLAN UPDATE

the group are recorded in the Plan. This group reviews the Human Services Transportation Coordination Plan. The process includes an update of the regional needs assessment, a review of and update of regional transit goals, capacity building and gap filling strategies, and the establishment of Regional Funding Priorities for the 5310 grant cycle.

#### **Transit Needs Assessment**

The core of the coordinated mobility planning process is the **needs assessment**. The needs assessment focuses on the identification and assessment of community transportation needs comparative to available resources. The purpose of this process is to help the public set goals, identify outcomes, develop strategies, and establish a network of transportation services that will meet customer and community needs.

The coordinated mobility planning process focuses on specific population groups that are more likely to be dependent on public transit and specialized transportation. These groups are often defined as **transit dependent** and include:

- Elderly: This includes all individuals 65 years of age or older.
- Individuals with disabilities: The FTA defines disability as "with respect to an individual, a
  physical or mental impairment that substantially limits one or more of the major life
  activities of such individuals. The phrase major life activities means functions such as caring
  for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing,
  learning, and work."
- Below poverty level: This includes individuals whose family income is at or below the 150 percent poverty line threshold.

#### **Transit Dependent Population Data**

To better understand the transit needs and demand for services of our transit dependent population demographic data was collected for each county. This data illustrates how transit dependent population groups are represented throughout the region in order to provide an understanding of the transportation needs that the Coordination Plan attempts to address. The sources for these datasets include the 2010 U.S. Census and the 2015 American Community Survey (ACS) Estimates. The following table reflects the data collected along with a 5-year demand estimate.

#### **Transit Needs Summary**

There are nine US States that have fewer square miles than the SEAGO region. Sierra Vista is the largest city in Cochise County with a population of nearly 50,000. Nogales, in Santa Cruz County, is its largest city with 21,392. Safford is the largest city in Graham County with a population of 9,653. Morenci and Clifton have a combined population of around 5,000 in Greenlee County. With a large geographical service area, and sparsely populated spaces that have a significant population of baby-boom generation and elderly, transportation needs within the SEAGO region are significant.

Within the region there are three FTA Section 5311, fixed route transit services, one each in Benson, Bisbee, and Douglas. The City of Sierra Vista operates a FTA Section 5307 fixed route transit system. All of these programs are located in Cochise County. There currently is no public transportation service that connects these systems. There are no fixed route systems in Santa Cruz, Graham, or Greenlee Counties.

Within the Section 5310 (Coordinated Mobility Program), the most often cited use of transportation is for health care, followed by access to shopping, appointments, and food/ nutrition. Access to jobs and job training are most often used by consumers with developmental disabilities and those who are seeking rehabilitation services.

As funding resources become scarce, funding priorities become more difficult. It is agreed that all transportation programs in the SEAGO region are important, valued, and essential to maintaining basic services and adding quality to the lives of riders who routinely depend on it. Programs that combine efforts, serve multiple client bases and/or serve large sections of the region will receive funding priority. New programs will be considered for recommendation only if they fill identified gaps in service.

Ridership numbers are going up across the region. With rising pressures on both sides (reduced funding and increased ridership), municipalities and organizations providing transit and transportation services will see greater unmet needs and ultimately larger gaps in service provision.

The SEAGO Region's senior population is highly dependent on "all-volunteer" programs such as the Sierra Vista Interfaith Caregiver Program (VICaP) and Senior Citizens of Patagonia. High operating costs are limiting program effectiveness. These programs are in need of operating funds to maintain service levels of over 17,000 riders annually.

Identifying efficiencies, potential for cost reductions, and opportunities for greater connectivity are priorities for the coming years in the SEAGO region. Without success in these areas, the region is at great risk of losing ground and ultimately losing essential transit/transportation.

In 2016, two transit Feasibility Studies were conducted in the SEAGO Region. The Graham County Feasibility Study focused on service that connected the communities of Safford, Thatcher, Pima, and the unincorporated areas of Graham County immediately adjacent to these communities. The Cochise County Intercity Route Feasibility Study focused on connecting service between the communities of Benson, Bisbee, Douglas, and Sierra Vista.

The firm Mobility Planners LLC was selected to conduct the Graham County Study. Mobility Planners utilized the Transit Cooperative Research Program (TCRP) Rural Transit Demand Estimation Tool to identify transit demand for services. The tool provides a realistic range of transportation need based on the number of persons living below poverty, the number of households without access to an automobile, and the trips per household per day for low income families based on national research. The following is a table created by Mobility Planners, LLC that provides the output from the TCRP Rural Transit Demand Estimation Tool:

Mobility Planners, LLC concluded that there is a significant need for additional public transportation in Graham County. The qualitative input from key stakeholders was unanimous on the need for public transportation. Based on national research the total need for transit, including both public transportation and human service agency transportation is approximately 257,000 annual trips. The following are locations that were consistently mentioned by stakeholders and focus group participants as key destinations for a transit service.

- Access to Eastern Arizona College
- Access to Medical Facilities
- Access to Shopping
- Access to Downtown Safford
- Access to Social Service Offices

The firm Moore & Associates, Inc. was selected to conduct the Cochise County Intercity Route Feasibility Study. Moore & Associates collected data from over 800 participants through public survey tools and public meetings. More than half of all respondents indicated Sierra Vista as the most common travel destination. 73 percent of the respondents indicated that would use a bus service between Douglas/Bisbee and Sierra Vista. 60 percent of the respondents indicated that they would use a bus service between Benson and Sierra Vista. The most common needs for service were:

- Access to Medical Services
- Access to Cochise College
- Access to Shopping
- Access to Work

The feasibility study found a high demand for interconnecting bus service. Annual ridership projected for the service is currently 64,818. The Cochise County Intercity Route Study can be accessed at www.cochisetransitplan.com

#### **Assessment of Needs by Population**

Based upon the data collected through these studies and information gathered though various public meetings, the following are our Regional needs based upon populations:

**Special needs populations**—includes transportation needs for developmentally disabled, persons with physical disabilities, persons addressing mental health issues, and the elderly.

Primary transportation needs for this population include:

- Health Care
- Food & Nutrition
- Jobs and Job Training
- Shopping, Social, and Recreational

Gaps include operating funds for existing 5310 programs sufficient to meet demand. Additional efforts to coordinate with Area Agency on Aging and with Health and Human Services agencies are a priority.

**Low Income populations**—includes transportation needs for those whose income is at or below 80% of area median income and for those who are working with State and local agencies to meet sustainable income goals.

Primary transportation needs for this population include:

- Access to Jobs
- Access to Job Training
- Health Care
- Food and Nutrition
- Shopping

The lack of transit connections to other communities is a significant barrier to employment, health, and education.

**General Public**—includes all other persons requesting transportation services. Primary transportation needs for this population include:

- Access to Jobs
- Access to Health and Human Services
- Access to Education
- Shopping
- Connections to other communities.
- Social

Gaps include fixed route service in Nogales, Safford, and Willcox, and connector services between communities. Additional efforts to coordinate intercity route possibilities with 5311 providers are a priority.

#### **Assessments of Needs by Geographical Area**

#### **Cochise County:**

- Connecting service between Douglas, Bisbee, Benson, and Sierra Vista
- Connecting service between Huachuca City and Sierra Vista
- Connecting service between Tombstone and Sierra Vista
- Connecting service between St. David and Benson
- Connecting service between Elfrida and Douglas
- Periodic service from outlying areas to Willcox

#### **Graham and Greenlee Counties:**

- Fixed route service in Safford
- Connecting service between Safford, Duncan, Clifton, and Morenci
- Connecting service between Safford and San Carlos Reservation

#### Santa Cruz County:

- Fixed route service in Nogales
- Connecting service between Nogales, and Rio Rico, Tubac, and Green Valley
- Connecting service between Nogales, Patagonia, and Sonoita

The SEAGO Region currently has 397 miles of public transportation access gaps that separate rural areas from our population centers that provide essential medical, food, social, shopping, and job access. The following map illustrates the current public transportation network within the SEAGO Region. Roadways outlined in blue indicate existing service. Roadways outlined in green indicate a planned rote that is scheduled to begin service in 2017. Roadways outlined in red indicate areas in which no access to public transportation is provided.



#### **Transportation Capacity Building and Gap Closing Strategies**

The following are the top 6 planning strategies developed during the 2014 coordination process. The intended purpose of these strategies is to increase public access to transportation services through capacity building efforts. Each strategy includes a 2017 update. While significant progress has been made, the Coordination Group is in agreement that each strategy requires additional work to stabilize the progress and should continue to remain active strategies.

**Strategy #1:** *Develop intercity bus service that links the public transit systems* of Benson, Bisbee, Douglas, and Sierra Vista and also provides access to national transportation providers (Greyhound and Amtrak) that have stops in Benson.

**2017 Update:** SEAGO applied for and secured a planning grant to conduct the Cochise County Intercity Route Feasibility Study. The first phase of the study was completed in December 2016. The study demonstrated a high need and demand for service. The study has moved into Phase 2 (Development of an Implementation Plan). The implementation plan is near completion and funding for the project has been secured. Service is expected to begin in August 2017. The service will provide access to public transportation to almost 90,000 area residents.

**Strategy #2:** *Pursue a FTA Section 5311 Program in the Safford area.* Currently the area has one FTA Section 5310 provider. That program focuses its transportation efforts on the elderly. There are no transportation programs that provide service to low income populations and the general public.

**2017 Update:** SEAGO partnered with Graham County to develop an Arizona Department of Transportation Planning Assistance for Rural Areas (PARA) grant to conduct the Graham County Transit Feasibility Study. The grant was awarded in June 2015 and the study was completed in April 2016. The study demonstrated a high need and demand for service. However, efforts to implement the program stalled due to the inability to secure local government match funding for the project. SEAGO is currently working with a local non-profit provider to pilot the project.

**Strategy #3:** *Develop a regional training program*. The coordination group strongly agreed that capacity building could be achieved through a coordinated training program that shared resources, standardized regional operating processes, introduced members to best practice information, and enhanced rider safety through a regionally provided Passenger Accessibility, Sensitivity, and Safety (PASS) program.

**2017 Update:** In April 2014, SEAGO successfully applied for a Mobility Management Training Grant to develop and deliver the training program. SEAGO developed a Coordinated Mobility Training Plan that developed the curriculum identified as a need by our coordination groups. SEAGO developed partnerships with other planning agencies around the State. The program SEAGO 2017-2018 TRANSPORTATION COORDINATION PLAN UPDATE

was funded again in 2015 and 2016. SEAGO will be applying for funding again in 2017. Over 300 people have been trained to date. Course evaluations have reflected that over 98% of the participants were very satisfied with the program and intended to use the training in their program. Strategy #4: Pursue funding sources outside of FTA Section 5310 and 5311 Grants. The coordination group felt strongly that programs cannot be solely dependent upon the above grant programs to fund their projects.

**2017 Update:** In 2016, SEAGO applied for a private foundation grant provided by the Legacy Foundation of Southeast Arizona. In May 2016, SEAGO was awarded \$600,000 to enhance access to health and wellness programs in Cochise County and southeast Santa Cruz County. SEAGO has used that funding to assist programs increase capacity through vehicle purchases, bus voucher programs for the homeless, veterans, domestic violence victims, and low income populations, new program development, and program outreach. SEAGO has worked closely with our Area Agency on Aging to maximize the use of Older Americans Act funding dedicated to transportation.

**Strategy #5**: *Increase the capacity of the region's all volunteer programs.* Volunteer programs are by far the most cost effective transit programs. The expansion of these programs volunteer base and transportation capacity could solve many of the region's transportation gaps in an economic manner.

**2017 Update:** SEAGO provided Legacy funding to our volunteer programs to hire outreach coordinators and to develop outreach materials. This effort resulted in the recruitment of 14 new volunteer drivers in the communities of Douglas, Bisbee, Tombstone, Benson, Willcox, Sunsites, Hereford and Palominas communities. SEAGO provided financial and technical assistance that resulted in two additional vans being integrated into these volunteer fleets.

**Strategy #6:** *Return a public transportation alternative to the Willcox area.* In 2014, the Northern Cochise Community Hospital ran a FTA Section 5310 program that provided over 18,000 rides annually to Willcox and its surrounding communities. They closed the program in September 2014. These riders were left without any means of public transportation.

**2017 Update:** In October of 2016, SEAGO was able to secure a vehicle transfer from a closing program for use in Willcox. SEAGO was able to develop a partnership with the Volunteer Interfaith Caregiver Program (VICaP) to restart the Willcox program. The program restarted in December 2016. SEAGO will be leveraging Legacy funding to support match requirements for a 2017 FTA Section 5310 grant application.

In 2012, SEAGO developed a Regional Mobility Management Plan for the SEAGO Region. Several public meetings and survey instruments were used to identify the planning priorities for a mobility management program. The Regional Mobility Management Plan can be accessed at www.azmobility.org. The following mobility management coordinating, funding and planning priorities resulted from that process:

#### **Priority #1: Communications**

- Sharing administrative resources including policies, procedures, and best practices;
- Continued support for Regional Mobility Management (Cochise, Santa Cruz, Graham, and Greenlee Counties);
- Development of Mutual Aid Agreements with local governments and providers.

**2017 Update:** SEAGO has worked with providers to standardize operating procedures and forms. Almost all providers in the region are using the standardized procedure and forms templates established by our coordination groups. SEAGO mobility management program hosts Coordination Meeting throughout the region and have over 35 programs participating in our coordination groups regardless of funding source. SEAGO has developed a Memorandum of Understanding in which 21 agencies have signed agreeing to share resources in the event of emergencies, staff shortages, and vehicle breakdowns.

#### **Priority #2: Efficiencies**

#### <u>Administrative:</u>

- Insurance shared or reduced costs,
- Centralized training program at a regional level, which will increase accessibility,
- Bus Pass reader— a system for tracking riders within a service area and particularly to track riders using multiple services across areas,

#### Operating:

- Combining transportation programs that have similar missions and geographical locations,
- Fuel Purchases collaborative purchasing possibly using state contracts,
- Increased operating funds availability,
- Use of State ADOT yards for vehicle maintenance, small repairs, and purchases of tires and other frequently replaced parts.

#### Capital:

- Access to hybrid or green fuel vehicles,
- GPS tracking for vehicles,

• Bus pass/card readers to track ridership and transfers between organizations,

**2017 Update:** SEAGO has developed a centralized training program as noted earlier in this report. SEAGO has developed a centralized vehicle inventory system that allows for vehicle usage tracking. SEAGO is working with providers to be the lead applicant involving a technology grant that would put tablets in our vehicles to capture ridership, vehicle inspections, and maintenance. SEAGO is in the process of conducting a Vehicle Maintenance Needs Survey among our providers in an effort to develop a planning grant application for the feasibility of a Regional Maintenance Center.

#### **Priority #3: Improved Service**

- Surveys of rider satisfaction,
- Review of routes and hours of operations to improve rider access when most needed,
- PASS Training, Defensive Driving Training for all drivers,
- Effective marketing to underserved populations and enhanced trip planning,
- Improved "How to Ride" information with greater outreach.

**2017 Update:** SEAGO has obtained a vehicle with a ramp that has enabled SEAGO to develop a come-to-you P.A.S.S. training model. SEAGO has the ability to transport mobility devices and training aids to our provider locations. This allows on-site training that saves agencies travel costs, staff time, and keeps valuable resources available. SEAGO has developed a Satisfaction Survey template that is available to all of our providers. SEAGO has developed a stand-alone mobility website (www.azmobility.org) that allows easy access to provider information.

#### **SEAGO Region Coordinated Mobility Funding Priorities**

The following are our regional funding priorities as identified through the regional prioritization process, Transportation Advisory Committee discussions, and discussions with local social service agencies and our Regional Section 5311 Public Transportation providers:

#### **Operating Funding**

As funding resources become scarce, funding priorities become more difficult. It is agreed that all transportation programs in the SEAGO region are important, valued, and essential to maintaining basic services and adding quality to the lives of riders who routinely depend on it. It is our goal to ensure that programs that serve the broadest client base and/or service area are giving the highest level of funding consideration. Operating requests should be considered in the following order:

- 1. Projects that have a broad mission that serve both the elderly and individuals with disabilities.
- 2. Projects that go "above and beyond" ADA requirements
- 3. Continued funding of existing programs that lack a public transportation alternative.
- 4. Continued funding of existing programs that actively participate in regional coordination activities.
- 5. New programs that address regional service gaps.

#### **Capital Funding**

It is our regional goal to ensure that all regional vehicles are safe and in good operating order (state of good repair). Therefore age and mileage will be considered. It is also important that program fleets are operated in the most cost effective manner possible. Therefore, fleet "right-sizing" is highly important. Therefore, an organization's number of vehicles and annual ridership should be considered prior to awarding replacement and/or additional vehicles. Capital requests should be considered in the following order:

- 1. Re-assign vehicles whenever possible.
- 2. Replacement of an existing program vehicle that has exceeded its ADOT identified "useful life".
- 3. New vehicle requests will be considered only when they fill regional service gaps.

#### **Mobility Management**

Mobility management has been recognized as an essential service to our transportation providers. It is a regional goal to create partnerships with transportation providers, social service agencies, government agencies and the general public in an effort to reduce costs, to enhance travel options, and to improve safety. It is also a goal to standardize program operations, training, and policy/ procedures, so that resources can be more effectively shared and program costs can be reduced. Mobility Management requests are considered in the following order:

- 1. Programs/projects that have the greatest impact to the region as a whole.
- 2. Sub-regional programs/projects that benefit a sub-section of the region.

#### **Project Ranking Process**

All of our Region's FTA Section 5310 programs are evaluated annually regardless of their intent to apply for funding. Points are awarded for their ability to meet the regional funding priorities as identified in the table below:

- Training Attended
- Safety Measures Implemented

- Program Expansion/Capacity Building Efforts
- Program Outreach Activities
- Program Compliance

# CATHOLIC COMMUNITY SERVICES

### House of Hope Domestic Violence Shelter

Catholic Community Services in Southeastern Arizona (CCS-SEAZ) operates the domestic violence shelter located in the city of Douglas in Cochise County. The House of Hope has a total of 24 beds available to provide services to men, women and children who are affected by domestic violence or sexual assault. The domestic violence shelters are committed to providing safety, shelter, advocacy, and empowerment to victims of domestic violence.

The shelter operates 24-hour crisis hotlines to provide information, referrals, and crisis counseling to victims of domestic violence. Callers may choose to enter the shelter to ensure their safety and security or they may choose to utilize services without becoming residents of the shelter. All services are provided free of charge to domestic violence victims regardless of age, race, national origin, income, or religion for any period of time up to 120 days.

The staff members at the CCS-SEAZ domestic violence shelter programs provide safety planning, referrals, case management, and legal advocacy to shelter residents and community members experiencing domestic violence. In addition to the above, shelter residents can participate in support groups, life skills trainings, and parenting classes. Transportation assistance is offered to meet the employment, education, legal, social services, and/or medical needs of the domestic violence victims served by the shelters.

Transportation assistance is a major component of the services provided to shelter residents and their children. Due to the rural location of the shelter, transportation is mostly necessary to the outlying cities where hospitals, behavioral health providers and other necessary services are located. Transportation to Tucson and Phoenix are often required as well depending on the severity of their case for court hearings and immigration issues.

Transportation assistance is provided on-demand and is essential for shelter residents trying to obtain and/or maintain employment in an effort to transition from the shelters.

Unmet needs include: \$80,000 in OPERATING FUNDS

CCS regularly participates in the Coordination Meetings.



## THE CITY OF BISBEE

#### **BISBEE BUS**

The Mission of the City of Bisbee Transit Program is to provide transit services that benefit the residents of the City of Bisbee and the surrounding area. Its mission includes providing safe reliable and affordable transportation service which is cost-effective, reduces energy consumption and contributes to the culture and economic betterment of the residents of Bisbee and the surrounding area.

The Bisbee Bus Program is a deviated, flex-route transit program serving the community of Bisbee with connecting service to Naco, AZ. It operates six days a week. Riders can request deviations from the route with a one day notice and be picked up and dropped off if the location is within one mile of the route.

The City of Bisbee has contracted with Douglas Rides to run the day to day operations of the Bisbee Transit Program. The program uses 5311 funds for its deviate d flex route service. Additional support to elderly riders and the disabled is received from SEAGO Area Agency on Aging.

Bisbee Bus staff meets quarterly with the regional Transportation Advisory Councils (TAC), including the City of Douglas TAC, City of Sierra Vista TAC, and City of Benson TAC and bi-monthly with the Cochise County Transit/Transportation Coordination group. In order to maintain the Bisbee Bus transit fleet, the City of Bisbee utilizes maintenance and repair services offered in-house, a formal Inter- Governmental Agreement with Cochise County and the City of Sierra Vista, or qualified and certified mechanics for major or warranty repair.

Identified unmet needs include operating funds to continue the existing transit program that serves elderly and disabled riders with reduced cost passes for service between Naco and Bisbee. Funds are being sought to expand a fixed route inter-city service to Sierra Vista, capital funds for video monitoring, GPS tracking, and data collection system.

- In the City of Douglas, Dial-A-Ride service is provided by the Douglas Rides program, and requires a 24 hour advance notice.
- Service to Elfrida is provided one day a week, every other week. Elderly and disabled clients are brought to Douglas for grocery shopping, nutrition services, and medical appointments.
- Through and agreement with Cochise College, students transportation is provided 4 days a week. As well as an inter-city connection to the City of Bisbee.

#### Identified unmet needs include:

- Expanding Inter-city service from Cochise College to Bisbee and possibly Sierra Vista. As a result of this expansion funds were requested to ADOT.
- Operating funds to meet the growth expectations of the existing transit program that serves the elderly and disabled riders with reduced cost passes for services, as well as the growth of the general public transit services.
- As the program continues to grow, it is imperative that ongoing training is provided to ensure that drivers and administrative staff are knowledgeable and up to date on training requirements.

The City of Douglas is an active participant in the Coordination efforts by regularly participating in the Cochise County Coordination meetings.

Recently designated as an urbanized area with a continuous population of over 50,000, the City of Sierra Vista, Vista Transit is currently in the process of transitioning from a 5311 to a Section 5307 grant funded system. The program operates five fixed routes in the City of Sierra Vista. In addition, Vista Transit offers curb to curb services for the disabled, Registration and a 24 hour advance notice are required. Services operate six days a week and utilize a fleet of 13 vehicles. All routes converge on the central transit station located on Willcox Drive where passengers can transfer to other routes.

The City of Sierra Vista is a significant participant in the monthly Cochise County Coordination meetings. They host the meetings in their facilities, provide training to regional transit/transportation providers, and provide intergovernmental agreements to cities and organizations that wish to utilize their maintenance and repair facilities.



With a highly trained staff, participants are guided in daily living activities. Douglas ARC has woven its transportation services into a trans-disciplinary approach with its clients. Using 5310 funds to purchase vehicles, Douglas ARC is able to provide a wide variety of services to consumers. Transportation is provided to appointments, medical care, shopping, and recreational outings.

In addition, a vocational program allows consumers to participate in meaningful employment opportunities. Staff transports participants to and from workplaces using trucks purchased from the past 5316 grant program.

Douglas ARC participates regularly in Transit/Transportation Coordination meetings. Jointly we are able to address transportation gaps and creative means of cost reduction. We are also able to consolidate our training programs, vehicle maintenance and repair. We also work closely with local transit providers when our services can complement other agency services.

Identified unmet needs include requesting operating funds. These funds will be used to purchase vehicle insurance, fuel, vehicle repair and maintenance. Plus a cut away van with a lift. The van to be replaced is a 2011 van with a ramp. This van has over 93,000 miles and will have over 100,000 miles, by the time the 2017 grant cycle vans are ready for delivery to agencies.

The Douglas Area Food Bank serves more than 3,900 residents in the Douglas, Pirtleville, McNeal, and Elfrida area each month. The Food Bank's mission is to provide food for the needy, and to educate the community on good nutrition as well as the prevention and control of chronic disease, especially Diabetes.

This area is very low income; almost 18% of the total population in Douglas uses the Food Bank on a monthly basis.

The Douglas Area Food Bank distributes food from local, regional and national donations, including food from The Emergency Food Assistance Program.

Some of the services provided by the food bank are:

- Diabetic awareness workshops held monthly for local residents/training.
- On-site healthy cooking classes are provided by The University of Arizona during the month, using the food distributed by the Food Bank.
- Work with SEAGO AAA to provide food boxes to the elderly and disabled in the community.
- Provide "home bound" service to 42 elderly clients who cannot come to the food bank because of their disability.
- Provide FEMA STORE shopping for those in need of emergency food.
- Partner with Chiricahua Community Health Center; medical staff provides on-site wellness checks to our recipients. They provide blood pressure monitoring, glucose testing, and weight control/measurements.
- Work with CSFP Program in Sierra Vista, Benson, and Willcox;
- SEAGO Transit Program. Pick-up residents 60 and older at their houses and bring them to our Food Bank location and return them home.

EHR strives to provide homes for adults with autism which focus on continually moving toward a more independent life. Equally important to independence is integration into the local community. Trained staff not only helps participants with activities of daily living but continually assess strengths and areas of interest that might be shaped into a volunteer/employment opportunity. GCRC, a nonprofit organization, has served individuals with developmental disabilities and/or physical limitations in rural Graham County since 1968. Individuals age 5 to seniors receive support in a variety of programs: Individual Designed Living Arrangements (IDLA) where they learn life skills and are transported to/from the grocery Adult and Children Day Programs and two store, doctor, etc.; supportive work sites where with the help of a job coach they learn job skills to secure local employment while earning a paycheck. Transportation to GCRC's various programs are "on demand" as each schedule is based on the needs of the individual and their families. Since there is no public transportation in Graham County, GCRC collaborates with other programs to provide transportation to social and community events for any individual with developmental disability and/or physical limitations. GCRC's fleet is also part of the Graham County Disaster and Pandemic plan.

GCRC programs are expanding capacity and the "on demand" transportation needs are increasing as a result of serving more individuals who need to get to and from work, grocery stores, school, doctor's appointments, etc.

### SANTA CRUZ TRAINING PROGRAMS, INC.

The Mission of Santa Cruz Training Programs, Inc. (SCTP) is working in partnership with others in the community, to provide necessary training and support for people with disabilities. Members develop a vision for their future as they learn to participate and contribute to their community. Participants learn to exercise more control over their lives, to establish and maintain relationships, and to practice self-respect, acceptance, and personal safety. Transportation is provided door to door to all of our members in the two Day Programs and Group homes. All of our programs require vehicles to provide transportation throughout the day.

Our Day Treatment and Training for Adults program (DTTA), offers transportation to their members, so they may participate in activities such as trips to do volunteer work or for physical and recreational purposes. DTTA is expanding to include a Semi-Retirement Program which will include older and more fragile members, thus needing to provide pick up and drop off hours, different than the regular members.

Our other day program is Employment Services which performs grounds keeping services through several local contractors. Members also prepare and serve food and pastries in SCTP's La Castellana Café. People in the community order food or pastries to be delivered to their home or place of business and members deliver these on a daily basis. This year we will add an additional service to our Employment Program called Transition to Work for new members wanting to participate in our Employment Program and they will require transporting those who attend at different times than the regular routes.

We have had two Group Homes for many years which we have a total of 8 adults residing there. They each have their own vehicle and provide transportation to the Day Programs, church, shopping and fun trips. We have been remodeling an old home to become our third Group Home and will require a vehicle to be available for them.

In January 2017 SCTP began to offer an 8 hour day to our members attending the day programs. About 90% are taking advantage of this, but those that are not, must be taken home earlier, so it has created another van route to accommodate them. There are also a few that cannot come to the day program till later in the morning, so we pick them up separately to meet their needs.

The majority of SCTP consumers are low income and about 50% live outside the Nogales city limits (Rio Rico, Tubac, Tumacacori and Patagonia Road areas).

SCTP is committed to participate in coordination efforts with agencies in the Santa Cruz County region. Staff members regularly attend Transit Coordination meetings scheduled. SCTP also coordinates vehicles with other agencies or elderly and disabled in the City of County when emergencies arise or when appointments or special events are scheduled.

- Operational Funding for existing programs.
- Local training opportunities for administrative staff and drivers to cover 3<sup>rd</sup> Group Home.


The Senior Citizens of Patagonia, Inc. is a 5013 (c) non-profit organization located in Patagonia, AZ. The mission of the Senior Citizens of Patagonia, Inc., is to serve and support senior citizens and disabled persons of any age who live in the Patagonia, Sonoita, Elgin and Canelo areas through assistance with transportation, nutrition, health, education and social services. The Patagonia Senior Center provides a location for congregate meals and social events.

The transit program has been in place since 1992, and is sustained by a volunteer transportation manager and several volunteer drivers. The service area is defined by the northern, eastern, southern county lines, and by a north south line running through mile marker 12 on Arizona highway 82. Clients are taken anywhere within a one hundred mile radius of Patagonia, excluding Mexico.

This transportation service is the only non-commercial option available to seniors and medically disabled in this area. Most of the service is performed between 7:00 am and 7:00 pm, M-F. However because volunteer drivers are the base of our staffing, most transportation needs can be met with planning. Services are only limited by the ability to secure a volunteer driver.

The Executive Director participates regularly in Transit Coordination meetings held in Sierra Vista and fully appreciates the information shared at these gatherings in terms of cost savings and service enhancement.

Identified unmet needs include operating funds to support the existing transportation program, a web based dispatch scheduling software, a training program for volunteer drivers and assistance in marketing the program.

SEACAP's transportation program covers Graham and Greenlee Counties, SEACAP is the only transportation available. While there are limited taxis, or public transit systems available in these very rural areas, these services are vital to these communities.

Vans, which are ADA accessible, are utilized to provide services to congregate meal sites, doctor visits, rental units for dialysis treatment, grocery shopping, paying bills, work sites and local DES. Transportation is also available to disabled students to attend the local Community College. These services are provided free of charge, but a donation box is available for those clients who wish to contribute to the program.

The number of individuals participating in our transportation program in the Graham County area at this time consists of 178 clients. A van serving this area is a 2011 cutaway with a lift. The Greenlee County area program consists of 166 clients. The 2 vans serving this area are 2013 Ford Cutaway vans with lifts. Due to our current funding restrictions, we have had to limit the number of Greenlee service hours.

SEACAP attends the coordination meetings and maintains a relationship with other regional agencies to address common transportation issues.

The Volunteer Interfaith Caregiver Program (VICaP) is a 501(c) (3) non-profit organization, based in Sierra Vista that provides vital transportation services for elderly, disabled, and homebound residents of Cochise County. Services offered by VICaP are free and offered by volunteers. Our mission is to help our "Neighbors: continue to live independently and maintain their quality of life.

In 2016 more than 111 highly trained volunteers provided specialized and individualized transportation services to those in need of VICaP's support. Approximately half of the volunteers can accommodate collapsible wheelchairs. VICaP Volunteers spent 13,773 hours, traveled 111,990 miles in their personal vehicles in order to provide this vital support to our Neighbors in Sierra Vista, Douglas, Bisbee and Benson last year. Monthly VICaP received over 400 calls for service.

VICaP participates in coordination efforts with other agencies, local health care providers and care facilities to ensure the needs of the clients are being met. VICaP regularly participates in the Cochise County Coordination meetings.

Wellness Connections is a non-profit 501 (C) 3 organization that serves adults with mental health disabilities; including members with co-occurring developmental, physical or substance abuse related disabilities. Wellness Connections also features a mobile outreach service for outlaying communities within the regions we serve. Currently, our program serve individuals enrolled in the Arizona public behavioral health system of care (Cenpatico), United States Veterans, Vocational Rehabilitation clients and Bridgeway/ALTCS members.

Services provided through Wellness Connections are delivered on a 1:1 basis or within groups led by peers. Programs provide members with opportunities to enhance their mental health and wellness achieve goals for personal growth and increase their ability to live as independently as possible in the community. Services include peer support, health groups, life skills, prevocational training, job coaching and transportation assistance.

Wellness Connections staff work in close collaboration with other local agencies to ensure transportation and other needs of our members are met. The staff participates in the bi-monthly coordination meetings. All staff providing transportation services are required to complete PASS driver training, CPR and First Aid training. They have also received training in psycho-social rehabilitation and peer support.

Currently, we have need for minivans with ramps or wheelchair lifts as well as support vehicles as we expand services throughout Cochise, Santa Cruz, Graham and Greenlee counties. We have continued to expand and grow at an exceptional rate for Wellness Connections. In order to meet the needs of our members, we will need to expand the fleet as well as transportation services. This expansion will come with an increase in fuel and maintenance costs. Our older vehicles are becoming increasingly costly to maintain, due to frequent repairs.
